IT IS HEREBY AGREED UPON BY BOTH PARTIES THAT THE FOLLOWING CONDITIONS WILL BE MET AND THAT NO OTHER WARRANTIES OR CONDITIONS ARE EXPRESSED OR IMPLIED.

BUYER certifies that he/she is not acting as an agent for another individual in the purchase of this dog, and will not sell this dog to any mass-producing kennel (puppy mill) or business. The purchase promises to keep the dog in a proper and safe manner. This puppy has been bred by us and has been carefully and attentively reared. The parent animals were mated with the aim of breeding good and healthy puppies.

Seller guarantees this dog to be free of communicable diseases as appears to the eye at the time of sale.

HEALTH GUARANTEE

At the expense of the buyer, this dog should be examined by a licensed veterinarian within 10 business days of possession to validate Health Guarantee.

We the seller cannot guarantee the puppy's size or color in adulthood. Due to the fact that the puppy leaves our home at a young age and the seller cannot guarantee that the puppy will breed or "finish" in a dog show.

If the puppy has a genetic defect detected by a licensed veterinarian within ONE year (guarantee ends when pup turns ONE year old) a full refund will be made or another dog of equal value, the choice to be determined by seller. The buyer must return puppy at the buyer's expense and puppy's AKC paperwork to the seller within 1 month of the exam that detected the defect before the replacement will be made. Seller must also have a letter from that Veterinarian with his address, telephone and the defect detected before any replacement puppy is given.

Should puppy die from communicable disease (this does not include parasitic infection or hypoglycemia) within 14 days of Purchase, and the buyer promptly sought treatment by a certified veterinarian, and if said vet certifies in writing that the puppy was thought to have been exposed prior to leaving our home, the buyer will get a FULL refund of PURCHASE PRICE of the puppy within 45 days of the certification of death (or autopsy report, which ever comes last). Buyer must send certificate (autopsy required only if the vet is unsure of the actual cause of the death) to the seller within 6 weeks of the pup's death.

Buyer is responsible for all transaction fees of original puppy and any potential replacement puppy. We, the sellers, are not responsible for veterinarian bills or any other bills once the puppy leaves our home.

If the buyer refuses to return this puppy for a replacement puppy, then this guarantee is null and void.

Buyer releases seller, Derrick Wengerd from any and all liabilities, and/or damages by fault of this dog after the time of sale. These damages include, but are not limited to, destruction of property and/or physical damage to any person or group of people. This contract is made out in duplicate; the seller and buyer each receive a copy.
